- 1. Technology Centers are responsible for the regional economy
 - a. Survival rate of Business in a technology center: 90%
 - b. Survival rate after leaving the technology center: 52%
- 2. Many Start Ups try to go international
- 3. Technology Centers have to accompany this going international.
